TERMS OF REFERENCE - 2008-2010

Role:

The role of the National COPMI (Children Of Parents with a Mental Illness) Reference Group 2008-2010 is to:

- provide guidance and advice with regard to strategies for implementation of the COPMI national initiative
- promote communication between the COPMI national initiative Team and the Reference Group members' networks
- assist the COPMI national initiative Team to keep abreast of developments in this expanding field.

Processes:

The Reference Group will achieve this outcome by:

- providing expert advice in regard to the development, implementation and evaluation of strategies within the national COPMI initiative
- facilitating networking and broad participation through sharing information with existing stakeholder networks
- participating in 'review and comment' of materials developed
- providing feedback about community perception of COPMI activities
- taking an active interest in achieving the initiative's outcomes to the best possible standard

Meeting schedule and reporting:

The Reference Group will meet on a 6 weekly basis via telephone conference. Communication with members between meetings will be via e-mail or telephone.

Meeting agenda and papers will be distributed electronically at least five working days before the scheduled meeting date. Minutes of meetings will be distributed electronically and placed on a password accessible page on the AICAFMHA website within 2 weeks of the meeting. Action items agreed during meetings will be clearly marked in the minutes. [NB: Members without access to electronic document transfer will receive papers by regular post.]

A maximum of one face-to-face meeting per annum may be called if

required. Transport and accommodation costs to attend will be met by AICAFMHA. Arrangements will be made for anyone unable to physically attend such meetings to link via telephone conference.

Remuneration: Professional members of the Reference Group will participate without remuneration. Appropriate remuneration arrangements will be made for consumers, carers and young people.
